Our registration of the shares of common stock does not necessarily mean that the selling stockholders will sell all or any of the shares.

Unless otherwise noted, each person or group identified possesses sole voting and investment power with respect to shares, subject to community property laws where applicable. None of the share amounts set forth below represents more than 1% of our outstanding stock as of February 21, 2001, adjusted as required by rules promulgated by the SEC.
