Item 2.02. Results of Operations and Financial Condition

OGE Energy Corp. (the "Company") is the parent company of Oklahoma Gas and Electric Company ("OG&E"), a regulated electric utility with approximately 786,000 customers in Oklahoma and western Arkansas, and OGE Enogex Holdings LLC and its subsidiaries ("Enogex"), a midstream natural gas pipeline business with principal operations in Oklahoma.

On August 4, 2011, the Company issued a press release describing the Company's consolidated financial results for the quarter ended June 30, 2011, which is furnished as Exhibit 99.01 and incorporated herein by reference. As described in the press release, the Company reported earnings of \$1.04 per diluted share for the quarter ended June 30, 2011 as compared to \$0.78 per diluted share for the quarter ended June 30, 2010. At OG&E, earnings were higher primarily due to a higher gross margin mainly due to extremely hot weather in OG&E's service territory partially offset by higher operation and maintenance expense. At Enogex, earnings were higher primarily due to higher natural gas gathering volumes and natural gas liquids prices.

OG&E posted earnings of \$0.79 per diluted share in the second quarter of 2011 as compared to \$0.61 per diluted share in the second quarter of 2010. Enogex posted earnings of \$0.25 per diluted share in the second quarter of 2011 as compared to \$0.19 per diluted share in the second quarter of 2010. The holding company posted break-even results in the second quarter of 2011 as compared to a loss of \$0.02 per diluted share in the second quarter of 2010.
