- (1) The restricted stock unit shall vest as to 25% of the shares on March 18, 2015 and 12.5% of the shares every six months thereafter, such that the shares are fully vested on approximately the four (4) year anniversary of the date of grant.
  - (2) The shares represent restricted stock units that were received as an award, for no consideration.
  - (3) Represents the maximum number of shares that will be earned, if at all, based on the achievement of a pre-established performance goal during the Issuer's fiscal year ending January 25, 2015. Each restricted stock unit represents a contingent right to receive one share of Issuer's common stock. The maximum number represents 200% of the target payout of 30,000 shares. If the pre-established performance goal is achieved, the shares earned will vest as to 25% on March 18, 2015 and as to 12.5% of the shares every six months thereafter, such that the shares are fully vested on approximately the four (4) year anniversary of the date of grant.
  - (4) Includes 1,040 shares purchased pursuant to the Issuer's Employee Stock Purchase Plan on February 28, 2014 and 5,125 shares issued upon the vesting of restricted stock units previously reported on a Form 4.
