American International Group, Inc. ("AIG" or the "selling shareholder") is offering 71,184,686 of AerCap Holdings N.V.'s ordinary shares. We will not receive any of the proceeds from the sale of the ordinary shares offered hereby.

Our ordinary shares are listed on the New York Stock Exchange ("NYSE") under the symbol "AER". On June 3, 2015, the closing sale price of our ordinary shares on the NYSE was \$50.34 per share. You are urged to obtain current market quotations for our ordinary shares.

The underwriters have an option to purchase a maximum of 10,677,702 additional ordinary shares from the selling shareholder.

We have agreed with the selling shareholder to repurchase \$750 million of our ordinary shares from the selling shareholder in a private transaction at the price per share paid by the underwriters in this offering. We expect the closing of the share repurchase to occur immediately prior to the closing of this offering, and the closing of the share repurchase is contingent on the satisfaction of all conditions precedent to the closing of this offering. The closing of this offering is not contingent on the closing of the share repurchase. See "Selling Shareholder Share Repurchase Agreement Share Repurchase and Notes Issuance."

Percentage Ownership of the Selling Shareholder:

Prior to the completion of this offering and the share repurchase, the selling shareholder beneficially owned approximately 46% of our ordinary shares outstanding as of March 31, 2015. Upon completion of this offering (but not the share repurchase), the selling shareholder will beneficially own approximately 12% of our outstanding ordinary shares (7% if the underwriters' option to purchase additional shares is exercised in full). If the share repurchase is completed, the selling shareholder will beneficially own approximately 5% of our outstanding ordinary shares (no ordinary shares if the underwriters' option to purchase additional shares is exercised in full). The financial information presented as of March 31, 2015 and for the three months ended March 31, 2015 and 2014 was derived from AerCap Holdings N.V.'s unaudited condensed consolidated financial statements included in our Report on Form 6-K dated May 20, 2015. The unaudited condensed consolidated financial statements have been prepared on a basis consistent with our audited consolidated financial statements and pursuant to the rules of the SEC and U.S. GAAP for interim financial reporting and include, in the opinion of management, all adjustments of a normal recurring nature to provide a fair statement of the results for the reporting periods presented. Results for interim periods are not necessarily indicative of results that might be expected for any other interim period or for an entire year.

On May 14, 2014, we completed the acquisition of ILFC. Consolidated financial statements from periods prior to the acquisition of ILFC may not be comparable to those for periods after the acquisition was completed.

RISK FACTORS

Investing in our ordinary shares involves risk. Those risks are specified below and in the section captioned "Risk Factors" in Item 3 of our Annual Report on Form 20-F for the year ended December 31, 2014, filed with the SEC on March 30, 2015, which is incorporated by reference in this prospectus supplement. You should carefully consider those risks together with the other information contained or incorporated by reference in this prospectus supplement before deciding to invest in our ordinary shares. If any of those risks actually occurs, our business, financial condition and results of operations could be materially and adversely affected. In that case, the trading price of our ordinary shares could decline, and you may lose all or part of your investment.

If the ownership of our ordinary shares continues to be highly concentrated, it may prevent minority shareholders from influencing significant corporate decisions and may result in conflicts of interest.

Currently, our largest shareholder is AIG, which owns 46% of our ordinary shares and is entitled, pursuant to the Shareholders' Agreement (as defined below), to designate for election at the Annual General Meeting of Shareholders two members of our Board of Directors for so long as it owns more than 10% of our ordinary shares. Once AIG ceases to own at least 10% of our outstanding ordinary shares, one of its designees will be required to resign from our Board of Directors. Upon completion of this offering (but not the share repurchase), the selling shareholder will beneficially own approximately 12% of our outstanding ordinary shares (approximately 7% if the underwriters' option to purchase additional shares is exercised in full). See "Selling Shareholder - Beneficial Ownership". If the share repurchase is completed, upon completion of the share repurchase and this offering, the selling shareholder will beneficially own approximately 5% of our outstanding ordinary shares (no ordinary shares if the underwriters' option to purchase additional shares is exercised in full). Because of its ownership of our ordinary shares, its board designation rights and certain agreements with us described in "Selling Shareholder - Other Relationships with AIG" below, AIG may be able to significantly influence fundamental corporate matters and transactions, including the appointment of our directors, mergers, amalgamations, consolidations or acquisitions, the sale of all or substantially all of our assets, the amendment of our articles of association and our dissolution. This concentration of ownership may delay, deter or prevent acts that would be favored by our other shareholders, such as a change of control transaction that would result in the payment of a premium to our other shareholders. In addition, this concentration of share ownership may adversely affect the trading price of our ordinary shares if the perception among investors exists that owning shares in a company with a significant shareholder is not desirable.

Sales of our ordinary shares may negatively affect their market price.

As a result of the ILFC Transaction (defined below), AIG acquired approximately 46% of our ordinary shares. The ordinary shares issued in the ILFC Transaction to AIG were subject to a lock-up agreement providing for the staggered expiration of lock-up periods beginning nine months and ending 15 months after the closing of the ILFC Transaction. Pursuant to the Share Repurchase Agreement described under "Selling Shareholder - Share Repurchase Agreement" below, we have agreed to waive this lock-up agreement to the extent necessary to permit this offering and the share repurchase. These lock-up restrictions applicable to AIG's remaining shares, if any, will expire on August 14, 2015. Sales by AIG of their ordinary shares, or the perception in the market that these sales could occur, may negatively affect the price of our ordinary shares.

The closing of this offering is not contingent on the closing of the share repurchase. See "Selling Shareholder Share Repurchase Agreement Share Repurchase and Notes Issuance." As a consequence, no assurance can be given to purchasers of the ordinary shares in this offering that the proposed share repurchase transaction will in fact be consummated.

We are subject to various risks and requirements associated with transacting business in many countries.

Our international operations expose us to trade and economic sanctions and other restrictions imposed by the United States, the United Kingdom, or other governments or organizations. For example, the U.S. Departments of Justice, Commerce, State and Treasury and other federal agencies and authorities have a broad range of civil and criminal penalties they may seek to impose against corporations and individuals for violations of economic sanctions laws, export control laws, the Foreign Corrupt Practices Act ("FCPA"), and other federal statutes and regulations, including those established by the Office of Foreign Asset Control ("OFAC"). Under these laws and regulations, the government may require export licenses, may seek to impose modifications to business practices, including cessation of business activities in sanctioned countries, and modifications to compliance programs, which may increase compliance costs, and may subject us to fines, penalties and other sanctions. A violation of these laws or regulations could materially and adversely impact our business, operating results, and financial condition.

On May 21, 2015, OFAC designated Al Naser Airlines of Iraq, a person and entity related to Al Naser Airlines, and nine individual aircraft, including two aircraft that we had previously sold to Al Naser Airlines, as blocked persons. Also on May 21, 2015, the U.S. Department of Commerce's Bureau of Industry and Security ("BIS") added Al Naser Airlines and another related person and entity to its Denied Persons List. The OFAC and BIS designations were based on Al Naser's reported diversion of the nine aircraft to a sanctioned entity, Mahan Air, in Iran, after purchasing the aircraft from multiple sources, and based on Al Naser's attempted purchase of other aircraft for the same purpose. Based on our internal review to date, there is no indication that the Company or any of its employees were aware of any such diversion. The BIS and OFAC investigations are ongoing and, in connection therewith, on May 27, 2015, OFAC issued a subpoena to the Company requesting information, including information related to other transactions that may have led to aircraft being diverted to Iran. The Company is cooperating fully with the investigations, which are in their early stages.

We have implemented and maintain in effect policies and procedures designed to ensure compliance by us, our subsidiaries and our directors, officers, employees, consultants and agents with respect to various export control, anti-corruption, anti-terrorism and anti-money laundering laws and regulations. However, such personnel could engage in unauthorized conduct for which we may be held responsible. Violations of such laws and regulations may result in severe criminal or civil sanctions, and we may be subject to other liabilities, which could materially and adversely affect our financial results.

Share Repurchase Agreement

Pursuant to the Share Repurchase Agreement, we and the selling shareholder have agreed to certain matters relating to the share repurchase, this offering and the issuance of the Notes, as described below.

Waivers Under Shareholders' Agreement and Registration Rights Agreement

Pursuant to the Share Repurchase Agreement, we and the selling shareholder have agreed, to the extent necessary to permit this offering and the share repurchase, to waive certain restrictions under the Shareholders' Agreement and the AIG Registration Rights Agreement (each as defined below), including certain transfer restrictions relating to lock-up periods and limitations on offering size.

Share Repurchase and Notes Issuance

Pursuant to the Share Repurchase Agreement, we have agreed to repurchase \$750 million of our ordinary shares from the selling shareholder in a private transaction at a price per share equal to the least of (i) the price per ordinary share paid by the underwriters to the selling shareholder in this offering, (ii) 104% of the last closing price per ordinary share reported on the NYSE prior to the public announcement of this offering and (iii) 110% of the opening price per ordinary share reported on the NYSE on the date of the Share Repurchase Agreement. The Share Repurchase Agreement provides that the consideration for the share repurchase will consist of the issuance of \$500 million in aggregate principal amount of Notes issued to the selling shareholder and the payment of \$250 million in cash to the selling shareholder.

Pursuant to the Share Repurchase Agreement, the Issuer will issue to the selling shareholder \$500 million in aggregate principal amount of the Notes, which will accrue interest at a fixed interest rate of 6.50% per annum until but excluding June 15, 2025, payable semi-annually. The Notes will accrue interest from and including June 15, 2025, until but excluding the maturity date or earliest redemption date, at a floating rate based on the three-month LIBOR rate plus 4.30%, reset quarterly, payable quarterly. The Issuer will have certain rights to defer interest payments on the Notes for one or more interest periods for up to five consecutive years per deferral period. Subject to the terms of the indenture governing the Notes, the Issuer may redeem the Notes, in whole or in part, at any time on and after June 15, 2025 at a redemption price of 100% of the principal amount redeemed, plus accrued and unpaid interest thereon. In addition, subject to the terms of the indenture governing the Notes, the Issuer may redeem the Notes, in whole but not in part, (1) upon a "rating agency event" (as defined in the Notes), at a make-whole redemption price, and (2) in the event that the Issuer may be required to pay additional amounts in respect of certain withholding taxes resulting from a change of law, at a redemption price of 100% of the principal amount redeemed, plus, in each case, accrued and unpaid interest thereon. If we experience a "change of control" followed by a "ratings decline" (each as defined in the Notes) (a "change of control triggering event"), the Notes may be redeemed at the Issuer's option, in whole but not in part, at a price of 101% of the principal amount thereof, plus accrued and unpaid interest, if any, to the date of the redemption. If (i) a change of control triggering event occurs and (ii) the Issuer does not give notice prior to the 31st day following the change of control triggering event to redeem all outstanding Notes, the interest rate per annum of the Notes will increase by 5.00%. The Notes will be guaranteed by AerCap Holdings N.V. and certain of its subsidiaries.

The closing of the share repurchase is contingent on the satisfaction of all conditions precedent to the closing of this offering and the satisfaction of certain other customary conditions. The closing of the share repurchase is expected to occur immediately prior to the closing of this offering. The closing of this offering is not contingent on the closing of the share repurchase and we cannot assure you that the share repurchase will be completed. See "Risk Factors – The closing of this offering is not contingent on the closing of the share repurchase."

The Share Repurchase Agreement provides that, upon the issuance of the Notes, the amount available under the AIG Revolver (as defined below) will be reduced by \$500 million.

Simultaneously with the closing of the share repurchase, the Issuer, the selling shareholder and the guarantors of the Notes (including AerCap) will enter into a registration rights agreement (the "Notes Registration Rights Agreement"). Under the Notes Registration Rights Agreement, the selling shareholder will have demand rights providing for the sale or distribution of the Notes in SEC registered offerings beginning 90 days after the closing of the share repurchase.

The information in this prospectus supplement regarding the share repurchase is included herein solely for informational purposes. Nothing in this prospectus supplement should be

Other Relationships with AIG

The following is a summary of material provisions of certain agreements we currently have in place with AIG, and should be read together with the information set forth under "Beneficial Ownership" above.

Shareholders' Agreement and Registration Rights Agreement with AIG

In connection with the closing of the ILFC Transaction, we entered into a shareholders' agreement, dated as of May 14, 2014, with AIG Capital Corporation and AIG (the "Shareholders' Agreement"), and a registration rights agreement, dated as of May 14, 2014, with AIG (the "AIG Registration Rights Agreement").

Board nomination rights

Currently, AIG is entitled to designate for election at the Annual General Meeting of Shareholders two directors of our Board for so long as it owns more than 10% of our ordinary shares, and for as long as AIG owns any of our ordinary shares, AIG is entitled to designate one director for election to our Board. Subject to the provisions of the Shareholders' Agreement, the Board will propose the AIG designated directors for appointment by the General Meeting of Shareholders. Once AIG ceases to own at least 10% of our outstanding ordinary shares, one of its designees will be required to resign from our Board of Directors. In addition, pursuant to the Share Repurchase Agreement, we may not grant any person the right to nominate more than two directors to the Board for as long AIG and its subsidiaries own any of our ordinary shares.

Restrictions on voting of shares

Currently, AIG may vote shares constituting up to 24.9% of shares able to vote, and pursuant to the Share Repurchase Agreement, following the closing of this offering and the share repurchase, AIG may vote shares constituting no more than 19.9% of shares able to vote, in each case (taking into consideration such voting restriction), and must abstain from voting the remainder of its shares. This voting restriction will not apply to, and AIG may vote 100% of its shares, in connection with:

any transaction requiring approval of a general meeting of shareholders under article 2:107a of the Dutch Civil Code (*Burgerlijk Wetboek*) ("DCC"), which includes an acquisition or disposition at a value in excess of one third of the total assets on a company's balance sheet, other than change of control transactions not approved by our Board;

any merger or sale of substantially all of our assets or other change of control transactions involving us, in each case approved by our Board;

changes to our organizational documents that would have a materially adverse and disproportionate effect on AIG relative to our other shareholders; and

any proposal at a general meeting of our shareholders to limit or exclude AIG's preemptive rights.

If AIG were to own less than 19.9% of the outstanding ordinary shares able to vote following this offering and the share repurchase, this voting restriction will cease to apply upon the completion of this offering and the share repurchase.

Until AIG holds less than 10% of the outstanding ordinary shares, AIG must abstain from voting any of its shares in connection with the election or removal of any director nominees not approved by our Board of Directors and any change of control transaction not approved by our Board of Directors.

Foundation structure

In the unforeseen event that AIG would challenge the enforceability of the voting restrictions in the Shareholders' Agreement, we are entitled to require AIG to transfer its shares to a Dutch foundation (*stichting*), in exchange for which AIG will receive a corresponding number of registered depository receipts from the foundation which will provide AIG with the economic benefits of its shares, while the voting rights will remain with the foundation.

The foundation would be subject to the same voting agreement as AIG, and AIG would be able to instruct the foundation how to vote on the specific matters on which AIG would be entitled to vote under the voting agreement provisions of the Shareholders' Agreement. The members of the board of the foundation would be appointed by us.

Lock-up periods

As a result of the ILFC Transaction, AIG acquired approximately 46% of our ordinary shares. Pursuant to the Shareholders' Agreement, the ordinary shares issued in the ILFC Transaction to AIG were subject to a lock-up agreement providing for the staggered expiration of lock-up periods beginning nine months and ending 15 months after the closing of the ILFC Transaction. Pursuant to the Share Repurchase Agreement, waivers of certain restrictions under the Shareholders' Agreement and the AIG Registration Rights Agreement, including certain transfer restrictions relating to lock-up periods, were granted to permit the sale of the ordinary shares in this offering and the share repurchase. All of the remaining shares, if any, owned by AIG following this offering and the share repurchase remain subject to a lock-up agreement expiring on August 14, 2015 (15 months after the closing of the ILFC Transaction), after which they may be sold subject to the other terms of the Shareholders' Agreement and applicable securities law.

Restrictions on transfer of shares

AIG may not transfer more than 9.9% of the outstanding shares to any one transferee, except in a bona fide broadly distributed underwritten public offering, and may not transfer any of the shares in connection with any tender offer, exchange offer or other acquisition not supported by our Board. Restrictions on the transfer of AIG's shares do not apply to transfers to us or wholly owned subsidiaries of AIG, or to transfers in connection with a merger or acquisition approved by our Board.

Standstill provisions

Until six months after the first date on which AIG owns less than 10% of the outstanding shares, AIG will be subject to customary standstill provisions.

Preemptive rights

If we issue equity securities for cash in an amount equal to or greater than 20% of our share capital, AIG, if the owner of any shares, will have customary preemptive rights, except to the extent such rights are limited or excluded by the general meeting of our shareholders, to purchase the portion of the issued shares required to maintain its ownership percentage in us.

Share repurchases

If we offer to repurchase shares from other shareholders, we are required to offer to repurchase AIG's shares pro rata.

Registration rights

The AIG Registration Rights Agreement provides that, subject to the lock-up periods described above, AIG has customary registration rights with respect to the ordinary shares it owns. Pursuant to the Share Repurchase Agreement, AIG may not, without our consent, launch any offering within 60 days of any other underwritten offering of ordinary shares held by AIG. AIG will continue to have registration rights with respect to any remaining ordinary shares following this offering and the share repurchase.

Specific performance

The parties have agreed that they will be entitled to seek an injunction or injunctions to prevent breaches of the Shareholders' Agreement and the AIG Registration Rights Agreement and to enforce specifically the terms and provisions of the Shareholders' Agreement and the AIG Registration Rights Agreement without proof of damages or otherwise in addition to any other remedy to which they are entitled.

Governing law, submission to jurisdiction and dispute resolution

The Shareholders' Agreement is governed by Dutch law and the AIG Registration Rights Agreement is governed by New York law. The Shareholders' Agreement provides that all disputes will be settled in the courts of Amsterdam, the Netherlands. The AIG Registration Rights Agreement provides that all disputes will be settled by arbitration in accordance with the Rule of Arbitration of the International Chamber of Commerce.

Compliance agreement

We and AIG have entered into a financial reporting and compliance agreement pursuant to which AerCap has agreed to, among other things, maintain certain compliance policies, provide AIG with reports and access to certain information and personnel and cooperate with AIG in complying with certain regulatory requirements.

\$1.0 billion revolving credit facility with AIG

In connection with the ILFC Transaction, we executed an agreement with AIG under which it provides us with a \$1.0 billion five-year unsecured revolving credit facility (the "AIG Revolver"), which became effective upon the consummation of the ILFC Transaction. AerCap Ireland Capital Limited is the borrower under the facility. Loans under the facility bear interest at, at the election of the borrower, LIBOR plus 375 basis points or a base rate plus 275 basis points. Amounts borrowed under the credit facility can be repaid and reborrowed up until maturity. The credit facility contains customary borrowing conditions, representations, covenants and events of default. Pursuant to the Share Repurchase Agreement, the amount available under the AIG Revolver will be reduced by the aggregate principal amount of the Notes upon the issuance of the Notes to AIG. The AIG Revolver was undrawn as of the date hereof. The Share Repurchase Agreement provides that, upon the issuance of the Notes, the amount available under the AIG Revolver will be reduced by \$500 million.

Other related party transactions with AIG

Derivatives: The counterparty of some of our interest rate swap agreements, which were acquired as part of the ILFC Transaction, is AIG Markets, Inc., a wholly-owned subsidiary of AIG, and these swap agreements are guaranteed by AIG. The net effect in our Consolidated Income Statements for the year ended December 31, 2014 from derivative contracts with AIG Markets, Inc., was nil, as the cash expense of \$4.3 million was offset by a mark-to-market gain of \$4.3 million. The net effect in our Condensed Consolidated Income Statements for the three months ended March 31, 2015 from derivative contracts with AIG Markets, Inc. was nil, as the cash expense of \$0.9 million was offset by a mark-to-market gain of \$0.9 million.

Management fees: As a result of the ILFC Transaction, we received management fees of \$4.9 million in the year ended December 31, 2014 from Castle trusts, affiliates of AIG. We received management fees of \$1.8 million in the three months ended March 31, 2015 from the Castle Trusts, affiliates of AIG.

Related party receivable: As of December 31, 2014, we had a receivable from AIG of \$5.7 million relating to reimbursements on compensation programs as part of the ILFC Transaction. As of March 31, 2015, we had a receivable from AIG of \$0.3 million relating to reimbursements on compensation programs as part of the ILFC Transaction.

The underwriting agreement provides that the obligations of the underwriters to purchase the ordinary shares included in this offering are subject to approval of legal matters by counsel and to other conditions. The underwriters are obligated to purchase all the ordinary shares (other than

those covered by the underwriters' option to purchase additional ordinary shares described below) if they purchase any of the ordinary shares.

The selling shareholder has granted to the underwriters a 30-day option to purchase up to 10,677,702 additional ordinary shares from the selling shareholder at the public offering price less the underwriting discounts and commissions. To the extent the option is exercised, each underwriter must purchase a number of additional ordinary shares approximately proportionate to that underwriter's initial purchase commitment. We and the selling shareholder have agreed to indemnify the several underwriters against certain liabilities, including liabilities under the Securities Act, or to contribute to payments the underwriters may be required to make because of any of those liabilities.

Price Stabilization, Overallotment Transactions, Syndicate Covering Transactions and Penalty Bids

In connection with this offering, the underwriters may purchase and sell ordinary shares in the open market. Purchases and sales in the open market may include stabilizing purchases, short sales, purchases to cover short positions, which may include purchases pursuant to the underwriters' option to purchase additional ordinary shares, and penalty bids.

Stabilizing purchases involve bids to purchase the underlying security so long as the stabilizing bids do not exceed a specified maximum.

Short sales involve secondary market sales by the underwriters of ordinary shares in excess of the number of shares the underwriters are obligated to purchase in this offering, which creates a syndicate short position.

"Covered" short sales are sales of ordinary shares in an amount up to the number of ordinary shares represented by the underwriters' option to purchase additional ordinary shares.

"Naked" short sales are sales of ordinary shares in an amount in excess of the number of ordinary shares represented by the underwriters' option to purchase additional ordinary shares.

These transactions may be effected on the NYSE or otherwise and, if commenced, may be discontinued at any time.

Most of the assets of our directors and most of our assets are located outside of the United States. As a result, it may not be possible to serve process on us or on such persons in the United States or to enforce judgments obtained in U.S. courts against them or us based on the civil liability provisions of the securities laws of the United States. Under our articles of association (i) certain disputes between, among others, our shareholders and us and or our directors must be exclusively submitted to Netherlands courts, and (ii) the legal relationships between, among others, those persons are governed by the laws of The Netherlands. We are advised that there is no enforcement treaty between the Netherlands and the United States providing for reciprocal recognition and enforcement of judgments, other than arbitration awards, in civil and commercial matters. Therefore, a judgment rendered by any federal or state court in the United States in such matters cannot automatically be enforced in the Netherlands. An application will have to be made to the competent Dutch court in order to obtain a judgment that can be enforced in the Netherlands. The Dutch courts can in principle be expected to give conclusive effect to a final and enforceable judgment of a competent United States court in respect of the contractual obligations under the relevant document without re-examination or re-litigation, but would require (i) proper service of process to have been given, (ii) the proceedings before such court to have complied with principles of proper procedure ("behoorlijke rechtspleging"), and (iii) such judgment not being contrary to the public policy of the Netherlands or the European Union. The court will have discretion to attach such weight to the judgment of any federal or state court in the United States as it deems appropriate and may re-examine or re-litigate the substantive matters adjudicated upon. Furthermore, a Dutch court may reduce the amount of damages granted by a federal or state court in the United States and recognize damages only to the extent that they are necessary to compensate actual losses or damages.

We have appointed Puglisi & Associates as our agent solely to receive service of process in any action against us in any U.S. federal court or the courts of the State of New York arising out of any offering or sale hereunder, as required by law.

Insofar as such indemnification for liabilities arising under the Securities Act may be permitted to directors, officers or persons controlling the registrant pursuant to the foregoing provisions, AerCap has been informed that in the opinion of the Securities and Exchange Commission such indemnification is against public policy as expressed in the Act and is therefore unenforceable. Under AerCap's articles of association, (i) the rights and obligations among or between AerCap and any of its current or former directors and officers, including the indemnification, are governed exclusively by the laws of the Netherlands; and (ii) any suit by and between AerCap and its current or former directors and officers shall be exclusively submitted to the courts of The Netherlands. When a current or former director or officer seeks to enforce the indemnification against AerCap before the courts of the Netherlands, such courts are not bound by the opinion of the Securities and Exchange Commission.
