- (1) The option was previously reported as an option for 40,000 shares of common stock at an exercise price of \$37.40 per share, but was adjusted to reflect WCI's 3-for-2 stock splits in the form of 50% stock dividends effective June 24, 2004 and March 13, 2007. Accordingly, on March 13, 2007, the number of shares purchasable on exercise of the option and its exercise price, as originally reported, were adjusted to 90,000 shares and \$16.62.
