Accelerated vesting will be contingent upon the Company's achievement of pre-determined performance goals, measured by total stockholder return (TSR) as compared to the TSR of the Company's competitor peer group.

(4) Includes 2,000 restricted stock units granted on March 15, 2005 under the same terms as described in footnotes 1 and 2 above.

(5) The options vest in three approximately equal annual installments beginning March 15, 2007.
