## Explanation of Responses:

- (1) Represents the weighted average price of shares sold at prices that ranged from \$27.98 to \$27.9801.
- (2) Represents 8,727 shares of common stock that remain unvested and which were a portion of the shares of common stock granted as a result of the company's achievement of certain performance criteria for 2013/2014 (the award was originally allocated to the reporting person as performance-based restricted stock units). 50% of the shares vested on the date of grant and the remainder will vest on 3/1/16.
