PLAINS EXPLORATION AND POGO PRODUCING SCHEDULE NOVEMBER 6, 2007 FOR SPECIAL MEETINGS OF STOCKHOLDERS

Houston, Texas, October 1, 2007 Plains Exploration & Production Company (NYSE:PXP) (PXP) or the Company) and Pogo Producing Company (NYSE:PPP) (Pogo) each scheduled November 6, 2007 as the date for their respective upcoming special stockholder meetings.
