Item 5.02. Departure of Certain Officers; Compensatory Arrangements of Certain Officers.

As stated in FormFactor, Inc.'s Proxy Statement for the 2008 Annual Meeting of Stockholders, FormFactor and Jorge L. Titingier, its Senior Vice President, Product Business Group, mutually agreed to eliminate Mr. Titingier's position as part of the company's restructuring activities in light of market and business conditions. Mr. Titingier's last day of employment with the company will be June 7, 2008. In connection with his departure, FormFactor and Mr. Titingier entered into a separation agreement and general release dated April 15, 2008 under which the company agreed to provide Mr. Titingier a severance payment of \$204,167, reimbursement of health benefits continuation coverage under COBRA through December 2008, executive outplacement services through a provider selected by the company and accelerated vesting of a portion of his restricted stock units representing an aggregate of 18,680 shares. Mr. Titingier signed a general release and waiver of claims in favor of the company, and continues to be bound by the company's employment, confidential information and invention assignment agreement.
