Additionally, PT was informed of the following transactions carried out by Avistar on 22 September 2011:

- § Acquisition of 5 million PT shares, over-the-counter, at an average price of Euro 5.40;
- § Execution of one call option and one put option in respect of 2 million PT shares, with maturity on 30 September 2011.
- § Execution of a Total Return Share Swap in respect of 3 million PT shares, with maturity on 7 October 2011

On 23 September 2011 Avistar also performed the following transactions :

- § Acquisition of 6 million PT shares, over-the-counter, at an average price of Euro 5.25;
- § Disposal of 6 million PT shares, over-the-counter, at an average price of Euro 5.20;
- § Execution of one call option and one put option in respect of 6 million PT shares, with maturity on 14 October 2011.

Finally, on 26 September 2011 Avistar also performed the following transactions:

- § Disposal of 2 million PT shares, over-the-counter, at an average price of Euro 5.41;

In addition, PT was informed that Avistar is a person closely related to PT's Non Executive Director Amílcar de Moraes Pires, as he is also Chairman of the Board of Directors of Avistar, and therefore this latter has the obligation to notify PT of such transactions pursuant to paragraph 4, b) of article 248-B of the Portuguese Securities Code.

According to information received from BES, after these transactions the voting rights attached to 104,935,960 PT shares, representing 11.70% of PT's share capital and corresponding voting rights, were attributed to BES.

This announcement is pursuant to article 248-B of the Portuguese Securities Code and article 14 of CMVM Regulation no. 5/2008 and follows a communication received from Banco Espírito Santo, S.A., a public company with registered office at Avenida da Liberdade, 195, 1250-142 Lisbon, Portugal, with a share capital of Euro 3,499,999,998.00, corporation number 500 852 367.
