Item 1.01 Entry into a Material Definitive Agreement.

On August 22, 2013, Huntsman International LLC (**HI**), a wholly-owned subsidiary of Huntsman Corporation (**HC**), entered into the Ninth Amendment (the **Amendment**) to the Credit Agreement dated as of August 16, 2005 (as amended, the **Credit Agreement**) with JPMorgan Chase Bank, N.A., as Administrative Agent.

The Amendment provides for a facility of additional term loans (the **Additional Term Loans**) pursuant to the Credit Agreement in the amount of \$100 million, the net proceeds of which will be used for permitted purposes under the Credit Agreement. The Additional Term Loans have terms identical to **HI**'s existing Extended Term B Loan Facility that matures on April 19, 2017.

The Additional Term Loans will amortize in an amount equal to 1% of the principal amount of the Additional Term Loans, payable annually commencing on March 31, 2014.

The foregoing does not constitute a complete summary of the terms of the Amendment. The description of the terms of the Amendment is qualified in its entirety by reference to such agreement, attached hereto as Exhibit 10.1 and incorporated herein by reference.
