**EXPLANATORY NOTE**

This Tender Offer Statement on Schedule TO relates to a possible tender offer by Vale S.A. ( Vale or the Company ), a corporation (*sociedade por ações*) organized under the laws of the Federative Republic of Brazil, for all or a portion of the Company's preferred class A shares (the Shares ), without par value per share, including Shares held in the form of American Depositary Shares. On the date hereof, Vale issued a notice (the Notification ) in Brazil relating to the possible tender offer. An English-language translation of the Notification is attached as Exhibit 1 hereto.

**The Notification is neither an offer to purchase nor a solicitation of an offer to sell any securities. Vale has not yet commenced a tender offer for the Shares. If required by applicable law and if the transactions described herein occur, Vale intends to file with the U.S. Securities and Exchange Commission a Tender Offer Statement and related materials on Schedule TO. Holders of the Shares and American Depositary Receipts representing the Shares are encouraged to read such documents carefully when they become available, and as they may be amended from time to time, before making any decision with respect to the potential offer, because they will contain important information. If and when filed, such documents will be available free of charge at the website of the U.S. Securities and Exchange Commission [www.sec.gov](http://www.sec.gov). In addition, if and when filed, Vale will provide copies of such documents free of charge to holders of the Shares.**
