## Explanation of Responses:

- The Google Stock Units ("GSUs") entitle the Reporting Person to receive one share of Google Inc.'s Class A Common Stock for each share underlying the GSU as the GSU vests. The GSUs vest as follows: 1/48th of GSUs shall vest on the 25th day of the first month after the vesting start date and an additional 1/48th will vest monthly thereafter, subject to continued service on such vesting dates. Vesting start date is July 6, 2011.
- (1) Vesting of GSUs grant of which was previously reported in Form 4.
  - (2) 1/48th of GSUs vested on July 25, 2012 and an additional 1/48th will vest monthly on the 25th day of each month thereafter, subject to continued service on such dates.
  - (3) 1/48th of the grant will vest on July 25, 2013 and an additional 1/48th will vest monthly on the 25th day of the month thereafter, subject to continued employment on such vesting dates.
  - (4) Each share of Class A Common Stock was issued upon the conversion of one share of Class B Common Stock at the election of Reporting Person.
  - (5) The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$874.86 to \$875.85, inclusive. The Reporting Person undertakes to provide to any security holder of Google Inc. or the staff of the Securities and Exchange Commission, upon request, full information regarding the number of shares sold at each separate price within the ranges set forth in footnotes (6) through (13) to this Form 4.
  - (6) These shares were sold in multiple transactions at prices ranging from \$876.31 to \$877.30.
  - (7) These shares were sold in multiple transactions at prices ranging from \$877.31 to \$878.30.
  - (8) These shares were sold in multiple transactions at prices ranging from \$879.58 to \$879.57.
  - (9) These shares were sold in multiple transactions at prices ranging from \$879.66 to \$880.65.
  - (10) These shares were sold in multiple transactions at prices ranging from \$880.82 to \$881.81.
  - (11) These shares were sold in multiple transactions at prices ranging from \$881.82 to \$882.81.
  - (12) These shares were sold in multiple transactions at prices ranging from \$883.34 to \$884.33.

  - (15) There is no expiration date for the Issuer's Class B Common Stock.
