- As previously reported, on February 3, 2012, Mr. Remondi was granted 53,158 bonus restricted stock units ("RSUs") representing rights to receive shares of SLM Corporation (the "Company") common stock in the future, which grant was approved by the Compensation and Personnel Committee (the "Compensation Committee") of the Board of Directors. One-third of these RSUs are settled on the first, second (1) and third anniversaries of the grant date by delivery of the Company's common stock. On February 3, 2014, 17,300 shares of such RSUs were settled and 1,025 additional shares were issued to Mr. Remondi upon the vesting of the related dividend equivalent rights, of which 8,075 shares were withheld by the Company (as approved by the Compensation Committee) to satisfy Mr. Remondi's tax withholding obligations.
