Performance Based Restricted Stock Units ("PBRSU") are scheduled to settle 100% in stock and vest one-third per year on March 1, (1) 2017, 2018 and 2019, subject to a performance based vesting hurdle (minimum Common Equity Tier 1 for well-capitalized Banks as established by the Federal Reserve Board).

(2) Each performance based restricted stock unit has the economic equivalent of one share of CIT common stock.

(3) Shares acquired upon final certification of performance share units awarded for the 2013-2015 performance period.
