- (1) 2,696 shares of Class A Common Stock were withheld by the Company to satisfy Mr. Haye's tax obligation upon vesting of 6,500 shares on January 2, 2018. The closing price of Class A Common Stock on January 2, 2018 was \$22.10.
- (2) On January 2, 2018, the Issuer entered into an agreement with John T. Hayes (the "Reporting Person") whereby the Reporting Person was granted a restricted stock award of 13,000 shares of Class A Common Stock that vests on January 2, 2023, pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").
- (3) Of such shares, 57,500 are restricted shares, subject to vesting, issued pursuant to the Restricted Stock Award Plan.
