Item 1. Security and Issuer

This Amendment No. 3 to Schedule 13D is filed on behalf of Glenn Peipert relating to the disposition of shares of common stock, par value \$0.001 per share (the "Shares"), of Conversion Services International, Inc., a Delaware corporation ("CSI") on August 23, 2006. The address of the principal executive offices of the Issuer is 100 Eagle Rock Avenue, East Hanover, New Jersey 07936.

Item 5. Interest in Securities of the Issuer

Item 5 is deleted in its entirety and replaced by the following new Item 5:

(a), (b) The Reporting Person beneficially owns 10,320,154 Shares, or 19.2% of the outstanding shares of Common Stock entitled to vote. The Reporting Person has sole voting power of all the shares of Common Stock he beneficially owns.

(c) On August 23, 2006, the Reporting Person acquired 974,122 Shares in connection with Conversion Services International's cancellation of \$613,696.87 of indebtedness owed by Conversion Services International to the reporting person. Thon conversion was made at \$0.63 per share, the closing sales price of Conversion Services International's common stock on such date.
