- (1) Options granted from the issuer's 2003 Stock Option Plan and vest 25% upon grant and 25% upon each subsequent anniversary date until fully vested.
- (2) This amended Form 4 is being filed solely for purpose of reporting repricing of options. On February 1, 2007, the issuer repriced the above stock options, which originally had an exercise price of \$0.239 per share, as follows: 1,250,000 which were vested as of February 1, 2007 were repriced to \$0.045; 625,000 options that vest on February 8, 2007 were repriced to \$0.075 per share, and 625,000 options that vest on February 8, 2008 were repriced to \$0.125 per share.
