- The Notes are linked to the performance of the Philadelphia Housing Sector<sup>SM</sup> Index and are not principal protected.
- Issue is a direct obligation of The Bear Stearns Companies Inc. (Rated A1 by Moody's / A by S&P).
- Issue Price: 100.00% of the Principal Amount (99.00% for investors who purchase a Principal Amount of \$1,000,000 or greater).
- If the Index Return is greater than zero, the Cash Settlement Value will be equal to the \$1,000.00 principal amount of the Note plus the product of (a) \$1,000 multiplied by (b) the Upside Participation Rate (300.00%) multiplied by (c) the Index Return; provided that in no event will the Cash Settlement Value payable at maturity exceed \$[1,420-1,450] per Note, which represents a maximum return of [42-45]% on the Notes.
- If Index Return is less than or equal to zero but greater than or equal to [-10.00]%, the Cash Settlement Value will be equal to the \$1,000.00 principal amount of the Note.
- If the Index Return is less than [-10.00]%, then the Cash Settlement Value for each Note will be equal to the \$1,000 principal amount minus 1% of the \$1,000 principal amount for each percentage point that the Index Return is less than [-10.00]%. DATE:** December [I], 2009 unless such date is not an Index Business Day, in which case the Calculation Date shall be the next Index Business Day. The Calculation Date is subject to adjustment as described in the Pricing Supplement under "Description of the Notes - Market Disruption Events."

**MATURITY DATE:** The Notes are expected to mature on December [I], 2009 unless such date is not a Business Day, in which case the Maturity Date shall be the next Business Day. If the Calculation Date is adjusted due to the occurrence of a Market Disruption Event, the Maturity Date will be three Business Days following the adjusted Calculation Date.

**CASH SETTLEMENT  
VALUE:** On the Maturity Date, you will receive the Cash Settlement Value, an amount in cash that depends upon the Index Return. The Cash Settlement Value, per Note, will be calculated as follows:

- (i) If the Index Return is greater than zero, the Cash Settlement Value will be equal to the \$1,000.00 principal amount of the Note plus the product of (a) \$1,000 multiplied by (b) the Upside Participation Rate (300.00%) multiplied by (c) the Index Return; provided that in no event will the Cash Settlement Value payable at maturity exceed \$[1,420-1,450] per Note, which represents a maximum return of [42-45]% on the Notes.

(ii)

If the Index Return is less than or equal to zero but greater than or equal to [-10.00]%, the Cash Settlement Value will be equal to the \$1,000.00 principal amount of the Note.

- (iii) If the Index Return is less than [-10.00]%, then the Cash Settlement Value for each Note will be equal to the \$1,000 principal amount minus 1% of the \$1,000 principal amount for each percentage point that the Index Return is less than [-10.00]%. For example, if the Index Return is -30%, you will suffer a 20% loss and, therefore, the Cash Settlement Value of each Note will be equal to 80% of the principal amount.

**INDEX RETURN:** Equals the quotient of (a) the Final Index Level minus the Initial Index Level, divided by (b) the Initial Index Level.

**UPSIDE PARTICIPATION RATE:** 300.00%.

**INITIAL INDEX LEVEL:** Equals [I], the closing level of the Index on December [I], 2007, as determined by the Calculation Agent.

**FINAL INDEX LEVEL:** The Final Index Level will be determined by the Calculation Agent and will equal the closing level of the Index on the Calculation Date as determined by the Calculation Agent.

**ILLUSTRATIVE HYPOTHETICAL CASH SETTLEMENT VALUE TABLE**

The following tables and graphs are for illustrative purposes and are not indicative of the future performance of the Index or the future value of the Notes.

Because the level of the Index may be subject to significant fluctuation over the term of the Notes, it is not possible to present a chart or table illustrating the complete range of all possible Cash Settlement Values. Therefore, the examples do not purport to be representative of every possible scenario concerning increases or decreases in the Index during the term of the Notes. You should not construe these examples or the data included in any table or graph below as an indication or assurance of the expected performance of the Notes. Numbers used in these examples may be rounded for ease of use.

You can review the historical levels of the Index in the section of the Pricing Supplement called “Description of the Index.” The historical performance of the Index included in the Pricing Supplement should not be taken as an indication of the future performance of the Index during the term of the Notes. It is impossible to predict whether the Final Index Level will be greater than or less than the Initial Index Level.

The examples demonstrating the hypothetical Cash Settlement Value of a Note are based on the following assumptions:

· Investor purchases \$1,000.00 aggregate principal amount of Notes at the initial public offering price of \$1,000.00.

· Investor holds the Notes to maturity.

· The Initial Index Level is equal to 150.00.

· The maximum return on the Notes is 44.00%, or \$1,440.00 per Note.

· The Upside Participation Rate is 300.00%.

All returns are based on a 24-month term; pre-tax basis.

No Market Disruption Events occur during the term of the Notes.

**Example 1: The Index Return is positive and the Cash Settlement Value is capped at \$1,440.00.**

In this example, the Index rises over the term of the Notes. On the Calculation Date, the Final Index Level is 225.00, representing an Index Return of 50.00%, as calculated below:

Because the Index Return is positive, the Cash Settlement Value will be equal to the \$1,000.00 principal amount of the Notes plus the product of (a) \$1,000.00 multiplied by (b) the Upside Participation Rate multiplied by (c) the Index Return; provided that in no event will the Cash Settlement Value payable at maturity exceed \$1,440.00 per Note. In this example, since the Index Return is greater than 14.66%, the Cash Settlement Value on the Maturity Date would be capped at \$1,440.00, which provides the maximum return on the Notes of 44.00%. This example illustrates the fact that the return on your Notes will be limited to the maximum return on the Notes of 44.00%.

**Example 2: The Index Return is positive.**

In this example, the Index rises over the term of the Notes. On the Calculation Date, the Final Index Level is 171.00, representing an Index Return of 14.00%, as calculated below.

Because the Index Return is equal to 14.00%, the Cash Settlement Value would be \$1,420.00, as calculated below.

In this example, the level of the Index rises 14.00% over the term of the Notes. Your return on investment, however, would benefit from the Upside Participation Rate and would be 42.00%.

**Example 3: The Index Return is negative, but is greater than -10.00%.**

In this example, the Index declines over the term of the Notes. On the Calculation Date, the Final Index Level is 138.00, representing an Index Return of -8.00%, as calculated below.

Since the Index Return is negative but is greater than -10.00%, the Cash Settlement Value would equal the \$1,000.00 principal amount of the Note.

In this example, the level of the Index decreases 8.00% over the term of the Notes, and your return on investment would be 0.00%.

**Example 4: The Index Return is negative and is less than -10.00%.**

In this example, the Index declines over the term of the Notes. On the Calculation Date, the Final Index Level is 97.50, representing an Index Return of -35.00%, as calculated below:

In this example, where the Index Return is less than -10.00%, the Cash Settlement Value would be \$750.00 because the Cash Settlement Value for each Note is equal to the \$1,000 principal amount minus 1% of the \$1,000 principal amount for each percentage point that the Index Return is less than -10.00%. In this example, the Index Return is -35.00%. Therefore, you will suffer a 25% loss and receive 75% of the principal amount of your investment at maturity. This example demonstrates that if the Index Return is less than -10.00%, you will lose some of your initial investment in the Notes.

**SELECTED RISK CONSIDERATIONS**

- **Suitability of Note for investment** - A person should reach a decision to invest in the Notes after carefully considering, with his or her advisors, the suitability of the Notes in light of his or her investment objectives and the information set out in the Pricing Supplement. Neither the Issuer nor any dealer participating in the offering makes any recommendation as to the suitability of the Notes for investment.

- **Possible loss of principal** - The Notes are not principal protected. If, on the Maturity Date, the Index Return is less than [-10.00]%, there will be no principal protection on the Notes and the Cash Settlement Value you will receive will be less than the initial offering price in proportion to the percentage decline in the Index. In that case, you will receive less, and possibly significantly less, than your initial investment in the Notes.

- **Maximum return of [42-45]%** - You will not receive more than the maximum return of [42-45]% at maturity, regardless of the positive percentage increase of the Final Index Level over the Initial Index Level. Because the maximum return on the Notes is [42-45]%, the maximum Cash Settlement Value is \$[1,420-1,450].

- **No interest, dividend or other payments** - You will not receive any interest, dividend payments or other distributions on the stocks underlying the Index, nor will such payments be included in the calculation of the Cash Settlement Value you will receive at maturity.

- **Not exchange listed** - The Notes will not be listed on any securities exchange or quotation system, and we do not expect a trading market to develop, which may affect the price that you receive for your Notes upon any sale prior to maturity. If you sell the Notes prior to maturity, you may receive less, and possibly significantly less, than your initial investment in the Notes.

- **Concentration** — Because the Index is comprised exclusively of companies whose primary lines of business are directly associated with the United States housing construction market, the stocks underlying the Index are concentrated in a single industry.

- **Liquidity** - Because the Notes will not be listed on any securities exchange or quotation system, we do not expect a trading market to develop, and, if such a market were to develop, it may not be liquid. Our subsidiary, Bear, Stearns & Co. Inc. has advised us that they intend under ordinary market conditions to indicate prices for the Notes on request. However, we cannot guarantee that bids for outstanding Notes will be made in the future; nor can we predict the price at which those bids will be made. In any event, Notes will cease trading as of the close of business on the Maturity Date.

**Taxes** - The U.S. federal income tax consequences of an investment in the Notes are complex and uncertain. We intend to treat the Notes for all tax purposes as pre-paid cash-settled executory contracts linked to the level of the Index and, where required, to file information returns with the Internal Revenue Service in accordance with such treatment. Prospective investors are urged to consult their tax advisors regarding the U.S. federal income tax consequences of an investment in the Notes. Assuming the Notes are treated as pre-paid cash-settled executory contracts, you should be required to recognize capital gain or loss to the extent that the cash you receive on the Maturity Date or upon a sale or exchange of the Notes prior to the Maturity Date differs from your tax basis on the Notes (which will generally be the amount you paid for the Notes). You should review the discussion under the section entitled "Certain U.S. Federal Income Tax Considerations" in the Pricing Supplement.
