This prospectus supplement (“Supplement”) modifies, supersedes and supplements information contained in, and should be read in conjunction with, that certain prospectus, dated May 11, 2010, related to the resale of our common stock from time to time by certain shareholders (“Prospectus”), of Neuralstem, Inc. (“Company”). This supplement is not complete without, and may not be delivered or used except in connection with, the Prospectus and all supplements thereto.

The information contained in this Supplement modifies and supersedes, in part, the information in the Prospectus, as supplemented. Any information that is modified or superseded in the Prospectus shall not be deemed to constitute a part of the Prospectus, except as modified or superseded by this Supplement.

We may amend or supplement the Prospectus from time to time by filing amendments or supplements as required. You should read the entire Prospectus and any amendments or supplements carefully before you make an investment decision.

REPRICING OF WARRANTS

On May 1, 2013, we received a proposal from Andrew Lessman (“Holder”). Pursuant to the proposal, the Holder agreed to exercise Holder’s Class C warrant to purchase 440,000 shares of the Company’s common stock (“Warrant”), for cash, in exchange for the Company: (i) reducing the exercise price of the Warrant from \$2.13 to \$1.07, and (ii) issuing Holder a replacement warrant to purchase 440,000 shares of common shares (“Replacement Warrant”). The terms of the Replacement Warrant are substantially similar to the Warrant, other than having an exercise price of \$1.25 and an expiration date of May 1, 2016.

This Supplement is being filed to reduce the exercise price of the Warrant from \$2.13 to \$1.07.
