Hollysys Automation Technologies Announces Ground-Based High-Speed Rail Signaling Contract Win for Harbin-Jiamusi and Jiuqing Lines

BEIJING, December 1, 2016 /PRNewswire/ -- Hollysys Automation Technologies Ltd. (NASDAQ: HOLI) ("Hollysys" or the "Company"), a leading provider of automation and control technologies and applications in China, announced today that it signed two contracts to provide the ground-based high-speed rail signaling system and equipment to Harbin-Jiamusi high-speed rail line ("Hajia Line"), valued at RMB 77.70 million or approximately USD \$11.23 million, and Jiuqing high-speed rail line ("Jiuqing Line"), valued at RMB 32.20 million or approximately USD \$4.65 million. Total value is RMB 109.9 million or approximately USD \$15.88 million.
