**Item 7.01. Regulation FD Disclosure**

On April 21, 2010, Global Partners LP (the “Partnership”) issued a press release announcing that the Board of Directors of its general partner, Global GP LLC, declared a quarterly cash distribution of \$0.4875 per unit (\$1.95 per unit on an annualized basis) on all of its outstanding common and subordinated units for the period from January 1, 2010 through March 31, 2010. On May 14, 2010, the Partnership will pay such cash distribution to its common and subordinated unitholders of record as of the close of business May 5, 2010. A copy of the Partnership’s press release is attached hereto as Exhibit 99.1 and incorporated herein by reference.
