Item 1. Security and Issuer

This statement relates to shares of the Common Stock, (the “Shares”), of Orion Energy Systems, Inc., a Wisconsin corporation (the “Issuer”). The address of the principal executive offices of the Issuer is 2210 Woodland Drive, Manitowoc, Wisconsin 54220.
