Under the terms of this plan, I will sell 8,000 shares on the 15th day of each month (or the next business day if the 15th is not on a business day) as long as the price is \$24.00 or higher. My plan also includes a provision for the sale of such shares at any time after such date as follows: 8,000 shares at \$27 or higher; 8,000 shares at \$28 or higher; 8,000 shares at \$29 or higher; and 8,000 shares at \$30 or higher.
