- (1) These restricted shares of common stock, par value \$0.0033, were issued pursuant to the provisions of the Amendment and Restatement of the 2001 Incentive Award Plan of Watson Pharmaceuticals, Inc. (including, but not limited to, restrictions on transferability and certain forfeiture provisions concerning unvested restricted shares). The restricted shares vest (i) fifty percent on the second anniversary of the first date of employment, and (ii) fifty percent on December 31, 2009.
- (2) The options are to be incentive stock options to the extent permitted by law, and thereafter to be non-statutory stock options.
- (3) These stock options shall become exercisable (i) 25% on the first anniversary from the date of grant, (ii) 25% on the second anniversary from the date of grant, and (iii) 50% on December 31, 2009.
