On April 27, 2010, the reporting person continued to be associated with the Issuer, resulting in the vesting and issuance of the remaining 7,500 shares of Common Stock so earned. The number of reported derivative securities also includes outstanding options for 120,000 shares of Common Stock.

On April 27, 2010, the reporting person continued to be associated with the Issuer, resulting in the vesting and issuance of another 6,000 shares of Common Stock so earned. The remaining 12,000 shares have been earned, but are not yet vested. The number of reported derivative securities also includes outstanding options for 120,000 shares of Common Stock.

The remaining 18,750 shares have been earned, but are not yet vested. The number of reported derivative securities also includes outstanding options for 120,000 shares of Common Stock.
