On August 23, 2012, an aggregate of 603 restricted shares previously issued to Mr. Curran vested in accordance with their terms and the terms of the plan under which such shares were issued. Mr. Curran elected to withhold an aggregate of 198 shares to pay the related taxes. As such, the number of shares actually issued was 405.
