- (1) Reflects the issuance of CUB common stock upon vesting of restricted stock units ("RSUs"). Each RSU granted at that time represented a contingent right to receive one share of CUB stock.
- (2) Shares withheld by CUB to satisfy the minimum statutory tax withholding obligations that arose upon the vesting of the RSUs.  
 This is the second of 4 vesting installments of RSUs granted to the Reporting Person on November 6, 2014. The remaining 2598 shares
- (3) from such grant shall vest in 2 equal installments on October 1, 2017 and 2018, subject to the Reporting Person's continuous service through such application vesting date.  
 This is the first of 4 vesting installments of RSU's granted to the Reporting Person on November 6, 2015. The remaining 4098 shares
- (4) from such grant shall vest in 3 equal installments on October 1, 2017, 2018 and 2019, subject to the Reporting Person's continuous service through each application vesting date.
