- Shares issued in settlement of vesting of performance restricted stock units ("PRSUs") granted on November 20, 2014. Each restricted stock unit ("RSU") represents a contingent right to receive one share of the Issuer's common stock; vested RSUs are payable in the form of cash, shares of the Issuer's common stock or a combination thereof, except as otherwise indicated below. To the extent vested RSUs are paid in shares of the Issuer's common stock, such shares will be delivered to the reporting person as soon as possible after vesting, but in no event later than two and one-half months after the end of the year in which vesting occurs, subject to the collection of withholding taxes.  - The RSUs, which include an aggregate of 5.5958 Dividend Units, vest in two equal annual installments beginning on November 20, 2017.
 - Date indicated is date of grant. Option vests in four equal annual installments beginning on the first anniversary of the date of grant.
 - The RSUs, which include an aggregate of 3.1069 Dividend Units, vest on November 19, 2017.
 - The RSUs, which include an aggregate of 3.0609 Dividend Units, vest on November 19, 2017.
 - The RSUs, which include an aggregate of 8.0732 Dividend Units, vest in two equal annual installments beginning on November 20, 2017.
 - The RSUs, which include an aggregate of 11.2298 Dividend Units, vest in three equal annual installments beginning on November 12, 2017.
 - The RSUs, which include an aggregate of 11.4785 Dividend Units, vest in four equal annual installments beginning on November 14, 2017.
