Also included are 1,593 shares held as custodian for son including 75 shares acquired as part of a (1) 5% stock dividend distributed 2/16/11 and 18 shares acquired in the DRP; Mr. Shara's total also includes 55,579 shares subject to a restricted stock award that has not yet vested. I: Includes 629 shares held by a family partnership of which Mr. Shara and his wife are general partners. Included in this total is 29 shares (5% stock dividend) and 13 shares (DRP).
- Reference is made to shares of restricted stock awarded under the Lakeland Bancorp Inc. 2009 Equity Compensation Program ("Plan"). Subject to vesting and transferability requirements and restrictions under the Emergency Economic Stabilization Act of 2008 ("EESA"), as amended by the American Recovery and Reinvestment Act of 2009 ("ARRA"), the Interim Final Rule promulgated by the U.S. (2) Department of Treasury on June 15, 2009, as applicable and as may be further amended, and the Plan, the shares of the restricted stock shall vest as follows: 45% on January 30, 2014, 45% on January 30, 2015, with the remaining 10% on the later of January 30, 2017 or the date on which the Company repays the Capital Purchase Program investment.
