Thornton is a limited partner of AVP IX LP and member of AVP IX LLC and may be deemed to share voting and dispositive powers over the shares held by AV IX. Mr Thornton disclaims beneficial ownership of shares held by AV IX except to the extent of any pecuniary interest therein.
