The shares indicated in Table I are subject to a Restricted Stock Unit grant representing a contingent right to receive shares of NHWK

(1) Common Stock upon vesting. The shares will become vested as to 1/4 of the total shares on each of the four anniversaries following the grant date.

(2) 16,500 of the shares indicated above are subject to a restricted stock unit grant that was originally reported as part of a 25,000 RSU grant in Table II on a Form 4 filed May 21, 2008. 5,062 of the shares listed above are held directly by the reporting person as a result of the vesting of 8,500 shares of the original RSU grant and the withholding of 3,438 shares for taxes.

(3) The option will become exercisable as to 1/24 of the total shares monthly, with the option being fully vested on May 19, 2011.
