These shares of participating preferred common stock are entitled to receive dividends at a rate of 7% per annum and may be converted at

(2) any time at a conversion price of \$23.30574 per share of common stock, subject to adjustment upon certain events specified in the certificate of designations.

(3) Time-based restricted stock vesting in four equal installments on May 27, 2011, May 27, 2012, May 27, 2013, and May 27, 2014.

(4) The 7% Cumulative Participating Convertible Preferred stock do not have an expiration date.
