(1) On 03/09/2011, the reporting person was granted an option to purchase 65,893 shares of Common Stock. The option vests based upon time (five equal annual installments that began on 03/09/2012) and performance (investment returns to investment funds affiliated with Bain Capital Partners, LLC, The Carlyle Group and Thomas H. Lee Partners, L.P. (collectively, the "Sponsors")) criteria.

(2) As a result of the sale of shares by the Sponsors on 08/15/2012, the performance criteria was met with respect to 26,019 shares of common stock subject to this option award, resulting in vesting of the option as to 5,207 shares and an additional 20,812 shares that are eligible to vest in four equal annual installments beginning on 03/09/2013. In total, following this event, the performance criteria has been met with respect to all of the shares of common stock subject to this option award (a portion of which has been exercised prior to the date hereof), with 5,207 of such shares still subject to issuance upon exercise having vested and become exercisable and the remaining 52,717 of such shares eligible to vest in four equal annual installments beginning on 03/09/2013.
