(1) Each restricted stock unit represents a contingent right to receive one share of HomeAway common stock.

The reporting person undertakes to provide to the issuer, any security holder of the issuer, or the staff of the Securities and Exchange Commission, upon request, full information regarding the number of shares sold at each separate price.

(4) Price reflected is the weighted-average sale price for shares sold. The shares were sold in multiple transactions, and the range of sale prices for the transactions reported was \$29.50 to \$30.28. (5) On March 27, 2012, the reporting person was granted 12,231 restricted stock units . 6.25% of the restricted stock units vest at the end of each quarter over a period of four years , measured from June 1, 2012, subject to continued service through each vesting date.

(6) 6.25% of the shares of Common Stock subject to the Option shall vest on the date which is three months following the Vesting Commencement Date and an additional one forty-eighth (1/48th) of the total number of shares of Common Stock subject to the Option shall vest on the corresponding day of each month thereafter, or to the extent such a month does not have the corresponding day, on the last day of any such month, and will be fully vested as of 04/01/2017.
