HSBC Holdings plc (the "Company")

This notification relates to the ordinary shares of the Company (the "shares") and is given in fulfilment of the obligations imposed under Section 198 of the Companies Act 1985 (the "Act").

We hereby notify you that on 17 June 2005, following disposals, CSFB (as defined below) holds the following interests in the issued share capital of the Company:

1. Credit Suisse First Boston (Europe) Limited ("CSFBEL"): 42,185,445 shares. CSFBEL has an interest in 29,654,178 of these shares under section 208(5) of the act by virtue of the right to redelivery of equivalent securities under stock lending arrangements.
2. Credit Suisse First Boston International ("CSFBi"): 186,374,445 shares.
3. Credit Suisse First Boston (Hong Kong) Limited ("CSFBHK"): 314,711,699 shares.
4. Credit Suisse First Boston LLC ("CSFBLL"): 201,965 shares.
5. Credit Suisse First Boston Capital LLC ("CSFBC"): 44,950 shares.

CSFB now holds a total interest of 543,518,504 shares being equivalent to approximately 4.84% of the issued share capital of the Company.

CSFBEL, CSFBi, CSFBC, CSFBLLC and CSFBHK are members of the investment banking business of Credit Suisse and reference to CSFB in this letter includes all of the subsidiaries and affiliates of Credit Suisse operating under the Credit Suisse First Boston name. Those CSFB companies, which are direct or indirect holding companies of CSFBEL, CSFBi, CSFBC, CSFBLLC and CSFBHK are under the terms of section 203 of the Act, each interested by attribution in any shares in which CSFBEL, CSFBi, CSFBC, CSFBLLC and CSFBHK are interested.
