Unilever NV announces that on 4 July 2007 it purchased 383,772 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 23.030 and euro 23.180 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 69,018 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 78,174,603 Unilever NV ordinary shares in treasury, and has 1,636,553,097 Unilever NV ordinary shares in issue (excluding treasury shares).
