Unilever NV announces that on 20 November 2007 it purchased 250,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 24.015 and euro 24.250 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 151,579 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, hold 115,142,605 Unilever NV ordinary shares in treasury and has 1,599,585,095 ordinary NV shares in circulation.
