QVT Financial LP ( QVT Financial ) is the investment manager for QVT Fund LP (the Fund ), which beneficially owns 42,571 shares of Common Stock. QVT Financial is also the investment manager for a separate discretionary account managed for Deutsche Bank AG (the Separate Account ), which holds 171,981 shares of Common Stock. QVT Financial has the power to direct the vote and disposition of the Common Stock held by each of the Fund and the Separate Account. Accordingly, QVT Financial may be deemed to be the beneficial owner of an aggregate amount of 214,552 shares of Common Stock, consisting of the shares owned by the Fund and the shares held in the Separate Account.

QVT Financial GP LLC, as General Partner of QVT Financial, may be deemed to beneficially own the same number of shares of Common Stock reported by QVT Financial.

The reported share amounts for each reporting person reflect an aggregate amount of 285,460 shares of Common Stock, or 7.49% of the then outstanding Common Stock, held as of May 3, 2004, as adjusted for subsequent purchases and sales during 2005 through the date of this statement.

Each of QVT Financial and QVT Financial GP LLC disclaim beneficial ownership of the 42,571 shares of Common Stock owned by the Fund and the 171,981 shares of Common Stock held in the Separate Account.
