1. Reason for share repurchase

To improve capital efficiency and to implement flexible capital policies in accordance with the business environment

2. Details of share repurchase

- (1) Class of shares: Common stock
- (2) Period of share repurchase: From February 13, 2006 to February 24, 2006
- (3) Aggregate number of shares repurchased: 91,130 shares
