Explanatory Note

As reported on May 10, 2007, the closing of the previously announced plan of arrangement involving Vista Gold Corp. (Vista), Allied Nevada Gold Corp. (Allied Nevada), and Carl and Janet Pescio (the Arrangement) occurred pursuant to the Arrangement and Merger Agreement, dated September 22, 2006, as amended, by and among the parties resulting in, among other things, the acquisition by Allied Nevada of Vista 's Nevada-based mining properties and related assets and certain interests in Nevada-based mining properties and related assets held by Carl and Janet Pescio.
