On March 14, 2008, MidWest*One* Financial Group, Inc., formerly known as ISB Financial Corp. (the Company), completed a merger with the former MidWest*One* Financial Group, Inc. (Former MidWest*One*). The Company was the surviving corporation in the merger. Pursuant to Rule 12g-3(a) of the Securities Exchange Act of 1934, the Company is deemed to be the successor issuer to Former MidWest*One* and, pursuant to Rule 12g-3(g), the Company is required to file an annual report for Former MidWest*One* covering the last full fiscal year of Former MidWest*One* prior to the Company succession. Because the merger was not consummated until March 14, 2008, the Company did not have sufficient time to complete and file Former MidWest*One* s annual report on or prior to March 31, 2008.
