**ChipMOS REPORTS OCTOBER 2010 REVENUE**

**Hsinchu, Taiwan, November 17, 2010** ChipMOS TECHNOLOGIES (Bermuda) LTD. ( ChipMOS or the Company ) (Nasdaq: IMOS) today reported its unaudited consolidated revenue for the month of October 2010.

Revenue for the month of October 2010 was NT\$1,407.1 million or US\$45.9 million, an decrease of 6.6% from the month of September 2010 and an increase of 22.9% from the same period in 2009. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$30.624 against US\$1.00 as of October 29, 2010.)

ChipMOS October 2010 consolidated revenues included revenues of ChipMOS TECHNOLOGIES INC. ( ChipMOS Taiwan ), ChipMOS U.S.A., Inc., MODERN MIND TECHNOLOGY LIMITED and its wholly-owned subsidiary ChipMOS TECHNOLOGIES (Shanghai) LTD. ( ChipMOS Shanghai ), and ThaiLin Semiconductor Corp. ( ThaiLin ).

The decline in October revenue is in-line with both overall market trends and with guidance provided on the Company's third quarter 2010 earnings conference call. ChipMOS continues to believe that revenues will bottom in the fourth quarter and show sustained growth beginning from the first quarter of 2011.
