This Statement is filed (i) by Exploration Capital 2008, as the direct beneficial owner of 2,500,000 Common Shares and warrants to purchase 2,500,000 Common Shares that are immediately exercisable; (ii) by Resource Capital by virtue of its position as General Partner of Exploration Capital 2008; (iii) by the Trust by virtue of its (A) direct ownership of 125,112 Common Shares and (B) indirect ownership and control of (1) Exploration Capital 2008 and Resource Capital (as owner of 100% of Resource Capital) and (2) Global Resource Investments Ltd. ( Global Resource ), a direct beneficial owner of Common Shares, as set forth below; and (iv) by Mr. Rule by virtue of his positions with Resource Capital, ownership interest in the Trust and another indirect beneficial ownership interest in Common Shares, all as described in the following sentences. Mr. Rule is President and a Director of Resource Capital, and, with his wife, is co-Trustee of the Trust, which owns 100% of Resource Capital and 100% of Rule Investments (as defined below).

Global Resource, which is not a Reporting Person, is the direct beneficial owner of 429,348 Common Shares and warrants to purchase 907,609 Common Shares that are immediately exercisable, aggregating approximately 2.1% of the Issuer's outstanding Common Shares. The corporate General Partner of Global Resource is Rule Investments, Inc. ( Rule Investments ). The Trust owns 100% of Rule Investments.
