Pursuant to General Instruction E of Form S-8, this registration statement on Form S-8 (the "Registration Statement") is being filed in order to register an additional 313,272 shares of the Registrant's Common Stock, par value \$0.001 per share, which are securities of the same class and relate to the same employee benefit plan, the AtriCure, Inc. 2008 Employee Stock Purchase Plan (the "Plan"), as those shares registered on the Registrant's registration statements on Form S-8 previously filed with the Commission on June 30, 2008 (Registration No. 333-152013), March 16, 2009 (Registration No. 333-157974), and March 30, 2010 (Registration No. 333-165780), each of which is hereby incorporated by reference. After giving effect to shares registered under this Registration Statement, the Registrant has registered 1,205,836 shares under the Plan.
