**Item 5.07 Submission of Matters to a Vote of Security Holders.**

On April 28, 2011, Surrey Bancorp (the Registrant) held its Annual Meeting of Shareholders (the Annual Meeting). There was one proposal submitted to shareholders at the Annual Meeting. In the case of Proposal 1, all of management's director nominees were approved and elected to serve on the Registrant's Board of Directors. The proposal below is described in greater detail in the Registrant's definitive proxy statement for the Annual Meeting filed on March 31, 2011, with the Securities and Exchange Commission.

The voting results were as follows:

***Proposal 1:*** Proposal to elect eight directors to serve a one year term until the Annual Meeting of Shareholders in 2012, or until their successors have been elected and qualified.
