On November 27, 2012, Orion Energy Systems, Inc. (the Company) received correspondence from Neal R. Verfuert in which Mr. Verfuert resigned from the Company's Board of Directors effective immediately as a result of an alleged disagreement with the Company. Mr. Verfuert was not serving on any committees of the Board of Directors at the time of his resignation. The Company believes that Mr. Verfuert's alleged disagreement relates to the Board of Directors' appointment of John H. Scribante as the Company's new Chief Executive Officer on September 27, 2012 in replacement of Mr. Verfuert, and/or the Board of Directors' subsequent termination of Mr. Verfuert's employment as Chairman Emeritus/Founder for cause on November 9, 2012. A copy of Mr. Verfuert's letter of resignation and further correspondence is attached hereto as Exhibit 17.
