Amendment No. 1 to Statement on Schedule 13D

This Amendment No. 1 (this Amendment) amends and supplements the statement on Schedule 13D filed by the Executors of the Estate of Kevork S. Hovnanian, Deceased with the Securities and Exchange Commission on October 26, 2009 (the Schedule 13D). Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in the Schedule 13D.

Item 4. Purpose of Transaction

Item 4 of the Schedule 13D is hereby amended by adding the following at the end thereof:

On December 18, 2012, the Executors, in their capacity as executors, contributed 970,849 shares of Class A Common Stock and 3,883,395 shares of Class B Common Stock to the Hovnanian Family 2012 L.L.C., a Delaware limited liability company (the 2012 LLC), in exchange for 100% of the limited liability company interests in the 2012 LLC. Following such transfer and pursuant to the terms of the Will, the Executors, in their capacity as executors, transferred all of their interests in the 2012 LLC to the marital trust created under the Will for the benefit of Sirwart Hovnanian.

Item 5. Interests in Securities of the Issuer

- (a) The Executors beneficially own 9,411,794 shares of Class A Common Stock in their capacity as executors, including 3,255,251 shares of Class A Common Stock receivable upon the conversion of a like number of shares of Class B Common Stock. The shares beneficially owned represent approximately 7.6% of the shares of Class A Common Stock, based upon 119,833,294 shares of Class A Common Stock outstanding as of December 14, 2012, as set forth in the Annual Report on Form 10-K filed by the Issuer on December 20, 2012, plus (for purposes of computing such percentage) the shares of Class A Common Stock receivable upon the conversion of such shares of Class B Common Stock. Such beneficial ownership represents approximately 14.5% of the combined voting power of the Class A Common Stock and Class B Common Stock.
- (b) The Executors, acting together, have sole power to vote or to direct the vote and to dispose or direct the disposition of the 9,411,794 shares of Class A Common Stock beneficially owned by them in such capacity. Ara K. Hovnanian, as special purpose Executor with respect to investments in securities of the Issuer, also has sole power to vote or to direct the vote and to dispose or direct the disposition of the 9,411,794 shares of Class A Common Stock beneficially owned by the Executors.
- (c) During the past 60 days, except as described in Item 4, the Executors, in their capacity as executors, have not effected any transaction in shares of Class A Common Stock or Class B Common Stock.
