ITEM 8.01 OTHER EVENTS.

On May 18, 2015, Farmers National Banc Corp. (Farmers) issued a press release announcing that it has received all requisite regulatory approval for the proposed merger of National Bancshares Corporation (NBOH) with and into Farmers and the related merger of NBOH 's wholly-owned subsidiary bank, First National Bank, with and into Farmers National Bank of Canfield, Farmer 's wholly-owned subsidiary bank. A copy of the press release is attached as Exhibit 99.1 to this Current Report on Form 8-K and incorporated herein by reference.
