**Item 1. Security and Issuer.**

This Amendment No. 8 (the Amendment ) amends and supplements the Schedule 13D filed by j2 Global, Inc., a Delaware corporation (the Reporting Person ), with the Securities and Exchange Commission on November 5, 2012, as amended (the Statement ), related to the Common Stock, par value \$0.01 per share (the Shares ), of Carbonite, Inc., a Delaware corporation (the Issuer ). The address of the Issuer s principal executive offices is Two Avenue de Lafayette, Boston, Massachusetts 02111.

Unless specifically amended or modified hereby, the disclosures set forth in the Statement remain unchanged.

**Item 5. Interest in Securities of the Issuer.**

Item 5 of the Statement is amended and supplemented as follows:

(a) As of the date hereof, the Reporting Person beneficially owns 1,658,177 Shares indirectly through a wholly owned subsidiary. According to the Issuer s Form 10-Q filed with the Securities and Exchange Commission on May 9, 2016, the number of Shares outstanding as of April 29, 2016 was 26,946,051. As of the date hereof, the Reporting Person is the beneficial owner of 6.15% of the Shares outstanding.
